Earliest postmark decides recipients.

**Government Scholarships:** 25 discounted registration fees of \$100 will be made available only to: (1) elected state, county or city officials, including Idaho State Legislators; (2) appointed state government board members; (3) judges and judicial staff; or (4) Congressional staff. To apply, submit your registration form and registration fee (or proof of request for fee) attached to your official letterhead. Earliest postmark decides recipients.

Additional committee meetings will continue Tuesday morning, with the Education (9:00 a.m.), Water Quality (10:00 a.m.) and Rural and Urban Affairs (11:00 a.m.).

**New this year, the main convention program will begin Tuesday afternoon (1:30 p.m.)** with a ½-day CLE session sponsored by our Water Quality Committee. The Convention will continue Wednesday morning, with a proposed program featuring a water supply outlook, IDWR and Bureau of Reclamation updates, Board Member training sessions, a discussion about capacity modeling at Aberdeen-Springfield Canal Company and other important water topics.

On Tuesday evening, at 5:00 p.m., we'll have our annual Meet and Greet Reception. We have invited Idaho State Governor candidates to attend. Our Annual Awards Luncheon will be held Wednesday at noon and our Legislative Banquet will end the convention on Thursday evening.
