As part of our ongoing effort to serve the needs of our membership, IWUA will be hosting its annual Applicator Recertification Workshops in February and March. The workshops will be held at the 2 locations listed below. The Jerome workshop is cancelled since the hotel no longer has meeting rooms. Next year we will hold the Magic Valley workshop in Twin Falls and then rotate back and forth between Rupert and Twin Falls in the future.

We will be applying for eight (8) credit hours with both the Idaho and Oregon State Departments of Agriculture. We will try have the following topics included in the program: Terrestrial Vegetation Management, Aquatic Weed Challenges, labels and labeling rules and regulations governing pesticides, mosquito abatement and others.

The **registration fee is \$40.00 per person**, which includes lunch and refreshment breaks. **Registration at all workshops will begin at 7:30 a.m.**, with the program starting at 8:00 a.m. Anticipated adjournment is 4:45 p.m.
